TO WHOM IT MAY CONCERN.

URGENT WARNING OF SERIOUS AND LARGE SCALE HARM CAUSED BY THE COVID VACCINES AND PLEA TO STOP IT AND TO REVERSE YOUR ANNOUNCEMENT THAT IT WILL BE GIVEN TO CHILDREN.

Dear Sirs and Madams,

I am a general practitioner who has been practicing as GP for 40 years now. I hereby inform and warn you directly and most seriously and urgently that I personally and daily consult and witness large scale damage to large numbers of patients who have received the covid vaccinations. Other doctors are seeing and reporting the same and you know that GP's and clinics will see the first signs of outbreaks of community health issues, and this is what I see and again warn you about. Numerous international researchers have found and reported the same. I have repeatedly reported my observations to the DOH and SAHPRA on the AEFI forms from July 2021, but the vaccines were not stopped.

I reported 125 cases to AEFI. 4 deaths. I attach a spreadsheet with 106 reports of up to 19/11/2022. About 40% of them were moderately to seriously affected. This constitutes only a fraction of all cases who complained of signs and symptoms since vaccination and a fraction of death reports from family members.

I also did three surveys amongst all patients visiting me and recorded how many of them were vaccinated or not. During 19 November 2021 to 24 Dec. 2021 and 28/3/2022 to 14/4/2022, I recorded 897 patients. 361 = 40% were vaxed. 268 = 30% were close contacts of vaxed. 268 = 30% were unvaxed. 1-14 November 2022 I repeated the survey and found the same results. I recorded 320 patients, 48% were vaxed, 21% were close contacts and 31% were unvaxed. **The only conclusion was that the vaccinations were UNSAFE AND INEFFECTIVE. Numberous international research reports confirm this conclusion.** I reported this to the DOH and SAHPRA, but the jabs are continuing.

I then started asking other general practitioners for their findings and I found that all of them experience this massive reports of adverse events from vaccinated patients. Sadly, only a few of them actually reported this to the DOH. We are about 20 000 GP's and primary health care facilities in SA. Each of them most probably will see similar numbers as mine. Therefore, my figures should be

multiplied by 20 000! So, the DOH reports are GROSSLY UNDERREPORTED. International researchers have found that only one out of 40 or more vaccine adverse events are actually reported in developed countries. It will be even far worse in SA.

Minister Phaahla, when several doctors and clinics reported that large numbers of people who ingested Escourt polonis got ill after ingesting it, the meat factories were closed immediately and intense investigations followed. The meat factories were only opened when the meat was perfectly safe. The same often happens when workers at a factory or a mine take ill or die. THE SAME SHOULD HAPPEN WITH THE COVID VACCINES. The only difference is that the vaccines do not cause immediate and similar reactions to all patients and the injured are spread over the country and over time. It is therefore not so obvious and needs insight and higher vigilance to pick this up and act – and that is where the DOH and SAHPRA and the whole reporting system miserably failed.

\* \* NB. Due to the fact that there is clear evidence of the dangers of these covid "vaccines" and the fact that children are not at risk for serious covid, and that there is safe and effective treatment, there is therefore no need for a covid "vaccine" for children, where the supposed cure and/or prophylaxis is more harmful than the disease.

IN CONCLUSION

- 1. Minister Phaahla, it is indisputable and obvious that the Covid vaccines are truly and seriously UNSAFE, DANGEROUS AND INEFFECTIVE.
- 2. Please immediately stop the administration of the covid vaccinations until the adverse events, safety and efficacy have been investigated in depth. Failure to do so will allow more and more people to be seriously hurt and many will die. The pandemic is over. There is no urgency and there is proven effective and safe alternative treatment for covid.
- 3. Please immediately reverse your decision to roll it out to children.
- 4. I will allow you until 5pm Wednesday afternoon 14/12/2022 to respond and to stop the vaccines and reverse your announcement that it will be given to children.
- 5. If you do not stop the vaccines, I will have no other ethical and moral option, but to proceed with urgent legal action to stop and prevent more harm to the people of SA.
- 6. We will also file criminal charges against you and everyone involved in approving of, administering of and advising the public that these covid injections are safe and effective. Every person who die will result in a murder charge.
- 7. Civil claims will also be instituted against every individual in person.
- 8. The warnings are out in the open. No one can claim a lack of knowledge.
- 9. Just listen to the accompanying video of Dr Robert Malone, one of many excellent experts warning about the dangers of mRNA injections.
